### CORRIGENDUM

Annex III in the document WFP/EB.3/2001/8/1 should be replaced by the attached Annex III.

In the Executive Summary, final paragraph, the figures should be US\$123.6 million and US\$66.7 million, respectively.

In paragraph 20, the second sentence should read, "The cost of the CP to WFP would amount to US\$142.4 million."

In paragraph 77, second bullet, the fourth sentence should read, "The total food requirement would be about 22,500 tons at a cost of US\$5.3 million."

In paragraph 77, fifth bullet, the final sentence should read, "This would amount to 123,000 tons over five years, at a cost of about US\$40.5 million."

Paragraph 79 should read, "For the proposed India Country Programme covering the period 2003–2007, the Executive Director requests the Executive Board to approve, subject to the availability of resources, US\$123.6 million, representing all basic operational costs, and to endorse US\$66.7 million for supplementary activities.
