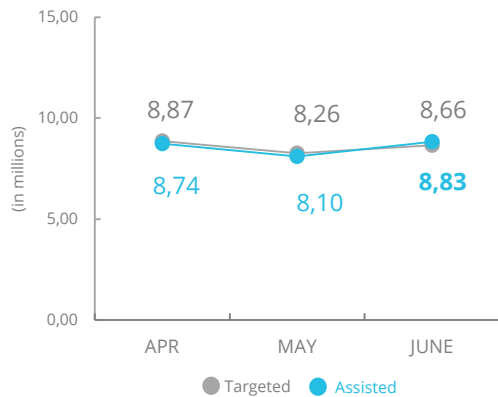

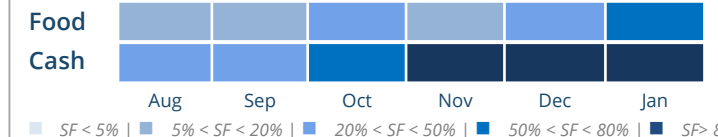


## AVERAGE MONTHLY FUNDING REQUIREMENTS

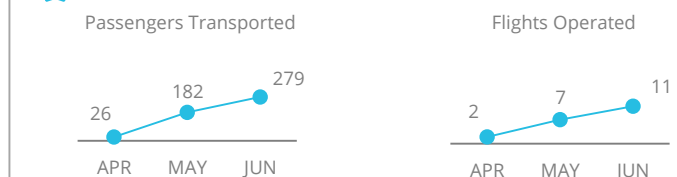

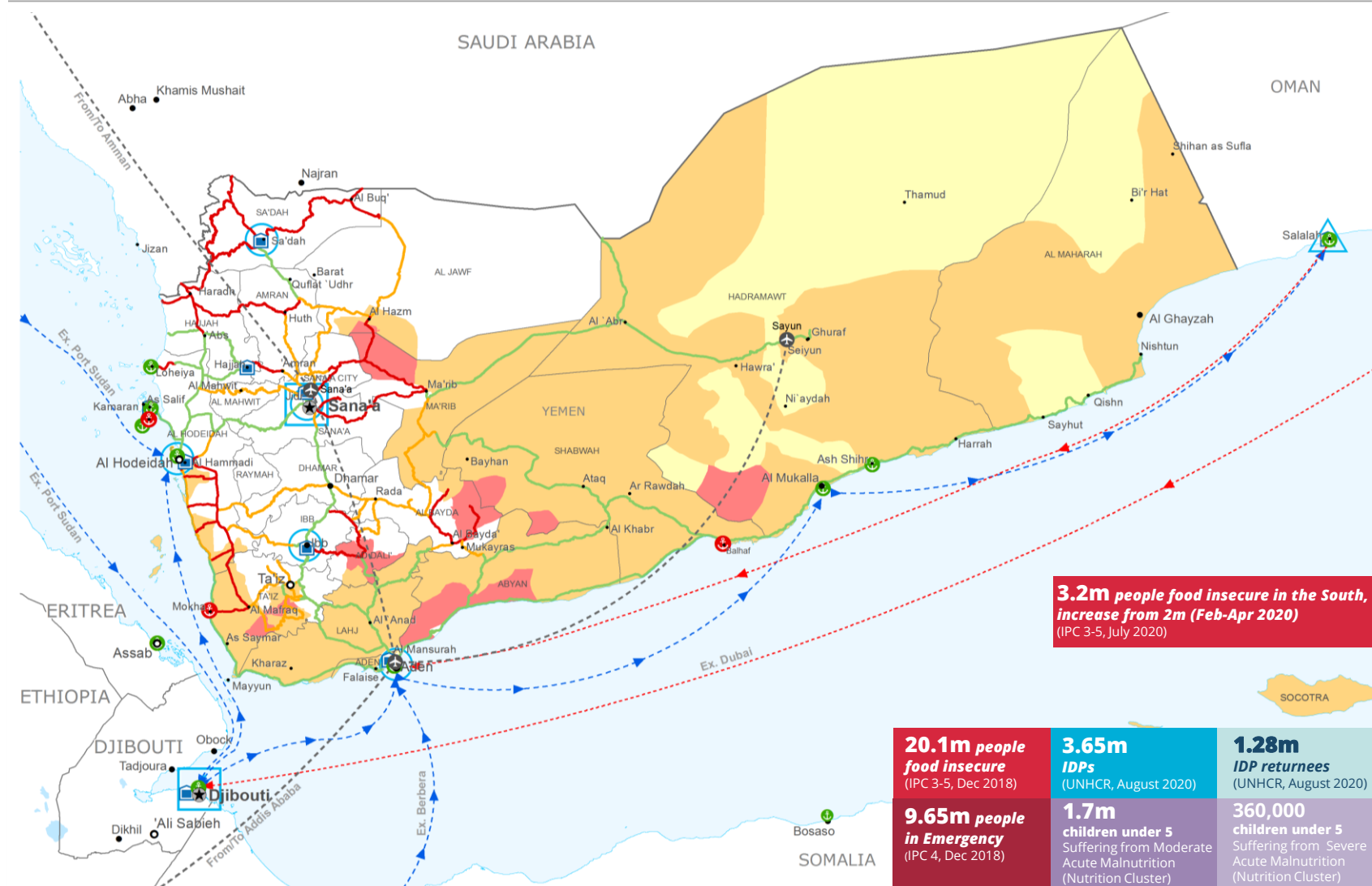
