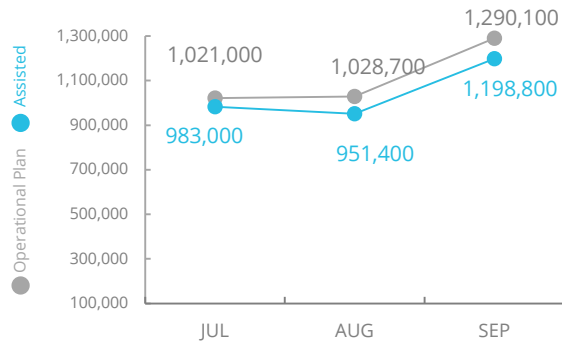


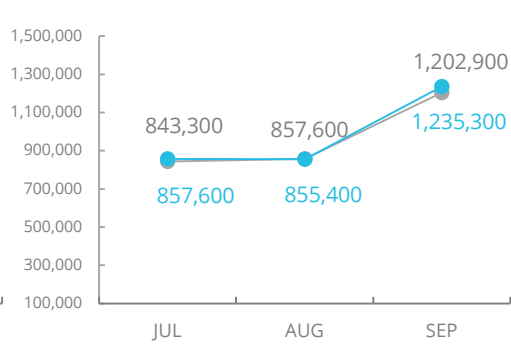

## PEOPLE ASSISTED Crisis Response

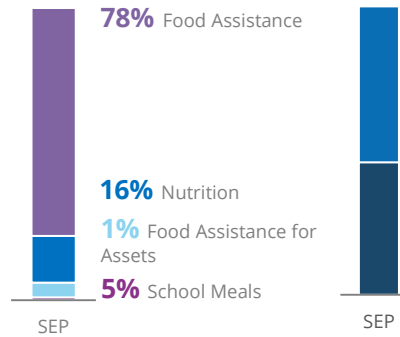

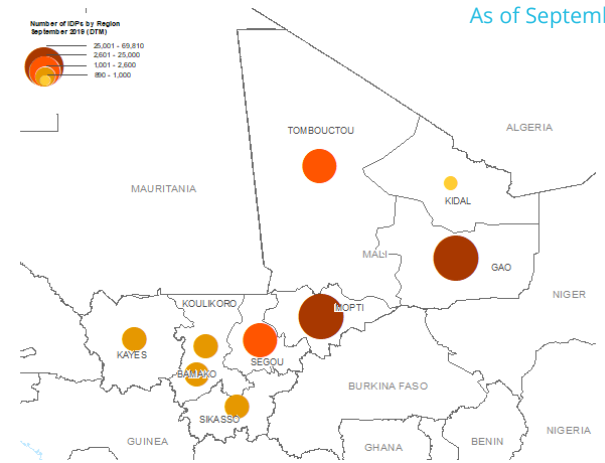

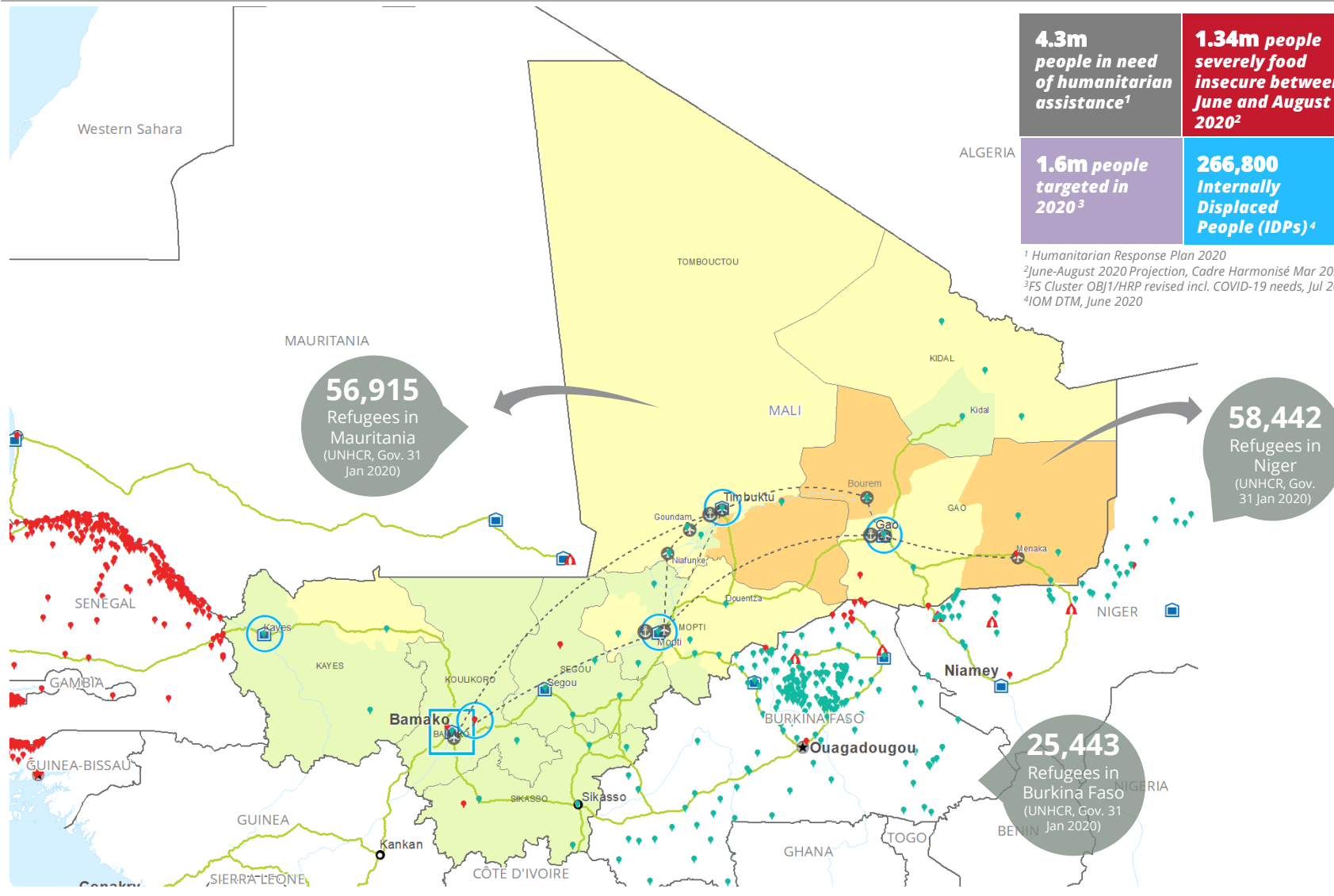

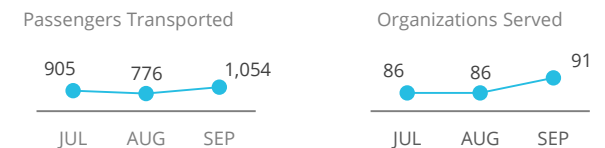
