Rationale

- 1. The current transitional interim country strategic plan (T-ICSP), covering the period 1 January-31 December 2018, has provided the opportunity for WFP to support the Government of Armenia in conducting a national food security and nutrition strategic review. The review was finalized in January 2018 and culminated in six main recommendations on how Armenia, with its national and international partners, could achieve food and nutrition security. The review included several rounds of consultations with the Government of Armenia, donors, United Nations organizations and the private sector and has informed the design of future WFP operations in Armenia.
- 2. The strategic direction of a country strategic plan (CSP) for Armenia for 2019–2023 was discussed with the Government of Armenia in early 2018. With the appointment of a new Government, however, a new round of government consultations is now required. The consultations will focus on the main strategic outcomes and activities of the proposed CSP and the resources and funding required to implement them.
- It is proposed that the end date of the current transitional ICSP be extended for six months

 to 30 June 2019 to give WFP and the Government of Armenia time to consult with stakeholders and partners and to explore new opportunities for long-term collaboration under a CSP for 2019–2023.

Changes

Strategic orientation

4. There will be no strategic changes during the extension of the current transitional ICSP. Outcomes and activities will remain the same.

Beneficiary analysis

5. No changes in the beneficiary caseload are envisaged.
