# Why post-harvest matters to the World Food Programme (WFP)

- In terms of WFP being perceived as an organization **capable of delivering not only in humanitarian situations, but also in development**, little compares to post-harvest loss in terms of **measurable impact** across all of WFP's portfolio of activities.
- Donors (governments, foundations, private sector) are increasingly investing money in post-harvest loss reduction efforts:
  - The European Union International Cooperation and Development (EU DEVCO) have funded Sudan's Zero Food Loss work with USD 15 million.
  - United Kingdom's Department for International Development (DFID) and Japan have funded refugee post-harvest in Uganda. DFID is on the cusp of funding an additional USD 5.5 million for post-harvest in food security crisis in Sudan.
  - Dreyfus, Archer Daniels Midland (ADM) and Cargill (three of the four world's largest grain traders), have already funded WFP post-harvest loss reduction activities in Uganda and Mali, and are preparing to expand to Madagascar and Burundi, and directly fund the WFP Global Post-Harvest Knowledge and Operations Centre.
- Empirical and independent evidence shows the impact of post-harvest loss reduction:
  - o Increased income, improved food security, health and nutrition are the three principal categories of impact.
  - According to the Massachusetts Institute of Technology's <u>MIT Independent</u> <u>impact assessment on WFP Post Harvest</u>, participating farmers' improvement was statistically significant for the following variables: food availability, family income, household health and nutrition, children's schooling, women's workload and socio-economic status.
  - Upcoming Kenya and Sudan Random Control Trials: Welfare, Nutritional, and Human Health Impacts of Post-Harvest Loss Prevention: A Large-Scale Field Experiment (IMPACT) with a sample size of 10,000 farmers in each country, in collaboration with Eidgenössische Technische Hochschule Zürich (ETH) and University of Zurich, funded by the Swiss Government and private foundations.
  - o In collaboration with Rome School Feeding and the Innovative Accelerator, initial results from School Feeding Hermetic Trials in Uganda show reduction in food losses, for schools in WFP's School Meals programme. Empirical results will be available at the end of the first school term in April 2019.

 WFP monitoring and evaluation show a reduction of post-harvest losses from 40 to 50 percent to less than two percent in Uganda, Sudan, Rwanda, Burundi, Tanzania, Zambia, Mali, Mozambique and Mali.
