1. Making reference to the draft full interim country strategic plan (ICSP) for Ethiopia for the period 2019–2020, this short-term ICSP consists of activities that continue WFP's current projects in the country. It seeks the Executive Board's approval by vote by correspondence of the implementation of such activities during the period from January to March 2019 pending the Board's approval of the ICSP at its 2019 first regular session. This early start is necessary to provide operational continuity until the Executive Board's approval of the ICSP.

- 2. To ensure adequate governance and oversight, all strategic outcomes and activities under the short-term ICSP are based on previously approved projects and ongoing activities. The short-term ICSP will include no strategic outcomes or activities that do not stem from existing projects, and such outcomes and activities will be implemented only under the ICSP after its approval by the Executive Board. Once approved, the ICSP will supersede this short-term ICSP.
- 3. Under the short-term ICSP WFP will assist the Government of Ethiopia and partners in working towards the following five strategic outcomes through nine activities:
 - Strategic outcome 1: Refugee and crisis-affected populations in targeted areas are able to meet their basic food and nutrition needs throughout the year (Sustainable Development Goal (SDG) target 2.1)

Focus area: Crisis response

Key activities:

- Activity 1: Provide unconditional cash-based and in-kind food assistance, livelihood support and emergency school feeding to crisis-affected people.
- Activity 2: Provide support for nutrition and the treatment of moderate acute malnutrition for crisis-affected children aged 6–59 months, pregnant and lactating women and girls and anti-retroviral treatment and tuberculosis-directly observed treatment clients.
- Activity 3: Provide unconditional cash-based and in-kind food assistance, school feeding and nutrition support to refugees and livelihood support to refugees and host populations.
- > **Strategic outcome 2:** Vulnerable and food-insecure populations are able to meet their essential food needs and establish climate-resilient livelihoods (SDG target 2.1)

Focus area: Resilience building

Key activities:

- Activity 4: Provide safe and reliable food to primary school children and support the Ministries of Education and Agriculture in scaling up nutrition-sensitive school feeding programmes.
- Activity 5: Provide conditional food assistance to chronically food-insecure households, disaster risk management solutions, economic empowerment of women and technical support to the Government for the implementation of the Productive Safety Net Programme.
- > **Strategic outcome 3:** Nutritionally vulnerable populations in targeted areas receive support aimed at preventing all forms of undernutrition (SDG target 2.2)

Focus area: Root causes

Key activity:

 Activity 6: Provide cash-based transfers for pregnant and lactating women and girls and children aged 6–23 months, combined with social and behaviour change communication, training for outreach workers and capacity strengthening for the WFP/EB.1/2019/8-C/7 3

Government in order to contribute to national efforts to reduce stunting and prevent undernutrition.

> **Strategic outcome 4:** Government institutions and the private sector benefit from capacity strengthening in the areas of early warning and emergency preparedness systems, the design and implementation of safety net programmes and supply chain management (SDG target 17.9)

Focus area: Crisis response

Key activity:

- Activity 7: Provide advisory and technical services to the Government and the private sector for strengthening delivery platforms and national systems, including early warning and emergency preparedness systems, safety net programme management and supply chain management.
- > Strategic outcome 5: Government, humanitarian and development partners in Ethiopia have access to and benefit from effective and cost-efficient logistics services, including air transport, common coordination platforms and improved commodity supply chains (SDG target 17.16)

Focus area: Crisis response

Key activities:

- Activity 8: Provide aviation-related services to government and humanitarian partners.
- Activity 9: Provide supply chain services to government and humanitarian partners.
