1. RATIONALE

On February 26, a magnitude-7.5 earthquake hit Papua New Guinea at a depth of 35 km, with the epicenter about 89 kilometers southwest of Porgera in Enga province. The earthquake destroyed access roads, destroyed water reservoirs and disrupted river flows, and the many landslides destroyed many of the root crops and vegetable gardens.

WFP responded to this earthquake with a four-month intervention plan by way of general food distributions and technical support to coordinate the overall supply chain management of the relief efforts to the humanitarian community and the emergency response. At the time, it was expected that WFP's intervention in this humanitarian response would conclude by 19th July 2018.

With the larger humanitarian response activities still ongoing, there's a continued need for support toward assuring effective and efficient logistics coordination. The Emergency Controller has requested through the UN Resident Coordinator, WFP's support in assisting the government in training staff as part of ongoing reforms in how the PNG government conducts relief operations.

This revision to extend the project in time with no increase in costs is therefore undertaken in response to this need.

2. CHANGES

The revision focuses on extending the duration of the LEO, stemming from the request for extended logistics cluster support. The LEO will be extended in time by 1.5 months from 19 July to 31 August 2018. This revision will change the total LEO duration to 5.5 months. No changes to the orientation and implementation arrangements originally outlined in the LEO document are anticipated with this revision.
