NATURE OF REVISION:

1. The purpose of this budget revision is to request a one-month extension in time until 30 April 2018 with no change in costs and objectives.

PROJECT BACKGROUND:

2. Hurricanes Irma and Jose, category 5 storms in the Atlantic Ocean, made landfall on the Eastern islands of the Caribbean through 07–10 September 2017. Around 70-90 percent of



houses and buildings were badly damaged on the islands due to storm surge, high waves and hurricane-force winds causing severe flooding, mudslides and flash floods. Roads and infrastructure were severely affected, especially in Anguilla, Antigua, Barbuda, Guadeloupe, Turks and Caicos Islands (TCI) and St Marteen.

3. Through this Special Operation, WFP, in its capacity as Logistics and Emergency Telecommunications Sector lead, and with its supply chain expertise in the area of aviation and shipping, aimed to support its relief efforts as well as those of the humanitarian community and CDEMA through its augmentation activities.

JUSTIFICATION FOR THE REVISION:

4. This extension in time will allow WFP to finalize operational activities, ensure an effective and gradual phase-out strategy of the services and equipment provided during the emergency, and finalize the confirmation of an in-kind contribution before the revised project end date.
