# 1. RATIONALE

- 1. WFP is accompanying the Government of Burkina Faso in its efforts to fight food insecurity and malnutrition through a new 5-year Country Strategic Plan (CSP). The plan covers the period 1 January 2019 to 31 December 2023. Informed by the national Zero Hunger Strategic Review, the CSP is articulated around six Strategic Outcomes and seven Activities with respective assistance modalities.
- 2. Since January 2016, the security situation in Burkina Faso has been increasingly worsening due to frequent attacks, targeted assassinations and kidnappings by non-state armed groups, mainly in the northern part of the country, resulting in forced displacement of thousands of people.
- 3. The deteriorating security context accompanied by a significant increase in new internally displaced populations and a surge of life-saving needs require humanitarian actors including WFP to provide immediate and effective relief assistance, including through the delivery of additional specialized nutritious products to meet the food and nutrition needs of crisis-affected populations and to help avert a deterioration of their nutritional status.
- 4. This budget revision (BR1) to WFP Burkina Faso CSP is required to allow the country office to add new assistance modalities and make necessary technical adjustments to continue providing timely and adequate assistance to targeted vulnerable populations.
- 5. More specifically, a new assistance modality (in-kind food) will be integrated under Activity 5 (Strategic Outcome 4), thereby allowing the country office to receive a pending USD 3 million contribution from USAID and plan related contributions for the following years.
- 6. The second major change through BR1 concerns the addition of high-calorie products such as BP-5 (*"Beredskaps Proviant"* or Preparedness Ration in English), a one-off donation from Norway, to the food baskets provided by WFP under Activities 1

(Strategic Outcome 1) and 2 (Strategic Outcome 2), in order to continue providing timely and adequate assistance to targeted vulnerable groups.

- 7. The third major change included in this BR1 will allow the Country Office to capture a contribution from the World Bank under Activity 7 (Strategic Outcome 6) to replenish Burkina Faso's National Strategic Food Reserve Agency or *Société Nationale de Gestion du Stock de Sécurité* (SONAGESS). Leveraging its supply chain capacity and technical expertise, WFP will purchase and transfer locally produced cereals to SONAGESS, the government agency in charge of managing the national security stock. The food stocks constitute a key safety net within the larger government-led social protection systems.
- 8. This BR will also enable technical adjustments in the Budget Planning Tool (BPT), in line with the new approved organisational chart.
- 9. The present revision does not affect the duration of the CSP, which is from 1 January 2019 to 31 December 2023.

# 2. CHANGES

### Strategic orientation

- 10. This budget revision does not affect WFP's strategic orientation in Burkina Faso which remains focused on saving lives and protecting livelihoods by delivering an integrated food and nutrition assistance package. The six Strategic Outcomes outlined in the CSP are still relevant, contributing to achieving the Government's priorities and objectives as delineated in the National Plan for Economic and Social Development (*Plan National de Développement Economique et Social, PNDES, 2016-2020*).
- 11. The present budget revision concerns four out of six Strategic Outcomes described in the CSP. BR1 seeks therefore to adjust WFP's food baskets, absorb pending and upcoming in-kind contributions for activities related to food assistance for asset creation (FFA) while ensuring effective and timely service provision to various national entities under Strategic Outcomes 1, 2, 4 and 6.

### Strategic outcomes

- 12. More specifically, this budget revision entails the following relevant changes:
- 13. Under Strategic Outcome 1: Activity 1, "Crisis-affected populations in targeted areas, including refugees, internally displaced people and host communities, are able to meet their basic food and nutrition needs during and in the aftermath of crises."
  - Inclusion in the food basket of high-energy BP-5 products;
  - 70 tons of BP-5 given by Norway and related costs will be taken into consideration as part of the current BR.
- 14. Under Strategic Outcome 2: Activity 2, "Food-insecure populations in targeted areas including school-age children, have access to adequate and nutritious food all year"
  - Inclusion in the food basket of high-energy BP-5 products;
  - 130 tons of BP-5 given by Norway and related costs will be taken into consideration as part of the current BR.

- 15. BR1 does not entail any change to Strategic Outcome 3. Nevertheless, under this outcome, the proposed budget for cereals was not generated in the approved Country Portfolio Budget (CBP). Following technical adjustments, a USD 130,000 increase of the budget has been generated, corresponding to the current value of the cereals.
- 16. Under Strategic Outcome 4: Activity 5, "Smallholder farmers and communities in targeted areas, including those affected by recurrent climate shocks, have more resilient livelihoods and sustainable food systems by 2023."
  - Addition of in kind-food modality as a new transfer modality;
  - 1,987 tons of in-kind food donated by USAID and related costs will be taken into consideration as part of the current BR;
  - This in-kind contribution will allow the Country Office to add 38,060 new beneficiaries under Activity 5, thereby contributing to addressing the growing urgent needs in terms of livelihoods enhancement.
- 17. Conditional cash-based transfers (CBT), vouchers and capacity strengthening, already taken into consideration, will remain.
- 18. Under Strategic Outcome 6: Activity 7, "Humanitarian and development partners benefit from common services that enable them to reach and operate in targeted areas all year."
  - This activity, whose initial budget was zero, will be activated following the request from the World Bank to use WFP's experience and expertise in food purchase to replenish the National Strategic Food Reserve Stock. Over USD 21 million will be transferred to WFP from the World Bank for this purpose.
- 19. Strategic Outcome 5 remains unchanged.

#### **Beneficiary** analysis

- 20. Targeted beneficiaries that WFP will serve through the CSP and especially under activities concerned by this budget revision have already been identified. Although this revision does not affect the category of targeted beneficiaries, the number of beneficiaries for Activity 5 will increase.
- 21. With regards to Activity 5 (Strategic Outcome 4), food and nutrition security analysis, especially the *Cadre Harmonisé* figures, will be used to target communities, particularly climate-affected smallholders. At household level, targeting will be based on community-based participatory approach. Once vulnerability criteria are defined together with the communities, WFP will apply them through a short questionnaire. A door-to-door survey will be used to identify potential beneficiaries. Using a scoring system, final beneficiary lists will be established and validated by community representatives. SCOPE will be used to register both cash-based transfers (CBT) and in-kind food beneficiaries whenever and wherever possible.

- 22. Strategic Outcome 1: Activity 1, distribution of high-energy products such as BP-5 as part of the food basket, in addition to previously identified food commodities.
- 23. Strategic Outcome 2: Activity 2, distribution of high-energy products such as BP-5 as part of the food basket, in addition to previously identified food commodities.

- 24. Strategic Outcome 4: Activity 5, food assistance in the form of in-kind food will be provided, in addition to conditional CBT and capacity strengthening (CS) that are the current assistance modalities for Activity 5. Considering the increasing trend of resilience needs in WFP targeted regions, the cash beneficiary caseload is not reduced.
- 25. Strategic Outcome 6: Activity 7, WFP will provide procurement services for the government agency responsible of the National Strategic Food Reserve using funding from the World Bank. This food reserve allows the Government to sell cereals at social prices (subsidized) and provide general food distribution to vulnerable people during food deficit periods. Through specific interventions directed towards vulnerable groups during the lean season, other partners including WFP complement the Government's operations.
