

Operational Context

The Kyrgyz Republic is a land-locked, mountainous country located at the centre of the Eurasian continent with a territory of 199,000 sq. km. The country borders China, Kazakhstan, Uzbekistan and Tajikistan. Two-thirds of the country's multi-ethnic population live in rural areas, which are the poorest areas, and a quarter of the population lives below the national poverty line of USD 1.3 per day. As of 2017, GDP per capita stands at USD 1,220.

The country's high dependency on imported basic food items, particularly wheat, continues to negatively affect the most vulnerable food-insecure households, who spend over half of their household income on food-related expenses. Poor food diversification can lead to malnutrition; in the Kyrgyz Republic, this translates into 13 percent of children aged 2 to 5 years suffering from stunting and 43 percent of children affected by anaemia.

Operational Updates

- In August, WFP implemented the "Purchase for Progress" pilot project to increase market opportunities for target smallholders and to support local economic development, national food security and the domestic production of staple foods through procuring food from amongst vulnerable smallholders. WFP competitively selected milling company "Dan-Azyk" in Osh province to participate in this project. Consequently, Dan-Azyk purchased wheat from WFP target smallholder farmers in Kara-Suu, Nookat and Aravan districts and used this wheat to produce fortified wheat flour for WFP project distribution. One hundred mt of wheat were purchased from local smallholder farmers by the milling company.
- WFP signed grant agreements with four local self-governments to transfer mini-processing equipment, under the funding from the Government of Japan, to support local food security and nutrition interventions focusing on vulnerable households. These target communities will be able to reduce their post-harvest losses and improve their value-added production using wool processing, fruit and vegetable drying, and canning equipment.
- On 21 August, WFP's School Feeding Programme had a
 meeting with the Director of the non-governmental
 organization (NGO) 'Good Neighbors International',
 based in the Republic of Korea, to discuss their joint
 project of a school-based bakery and greenhouse in
 Chuy Province. The project envisages the opening of a
 local bakery in the village of Kamyshanovka which will
 produce products for the entire village and may
 distribute their bakery products to neighboring
 villages. This project will create additional jobs for
 those in the community.
- Throughout August the WFP Representative had a series of meetings, including a courtesy meeting with the Ambassador of China to the Kyrgyz Republic, and a meeting with the Ambassador of the Russian Federation to the Kyrgyz Republic, to discuss further collaboration and partnerships. WFP is organizing a dedicated field visit for the Ambassador of the Russian Federation to Talas province in mid-September.

Strategic Result 1: Everyone has access to food

Strategic Outcome 1: All primary school-aged children in the Kyrgyz Republic have access to safe, adequate and nutritious food all year round *Focus area: Optimizing School Meals*

Activities:

 Provide school meals to primary school-aged children and strengthen the capacity of government institutions and schools to implement school meals

Strategic Result 3: Smallholders have improved food security and nutrition through improved productivity and incomes

Strategic Outcome 2: Vulnerable and food insecure smallholders, in particular women, in the most vulnerable geographic areas of the Kyrgyz Republic, have enhanced livelihoods and increased resilience to shocks to better support food security and nutrition needs all year round **Focus area:** Supporting smallholders

Activities:

- Provide support in productive assets creation to vulnerable communities and food insecure smallholders
- Provide capacity strengthening to food insecure smallholders

Strategic Result 4: Food systems are sustainable

Strategic Outcome 3: Food-insecure communities in areas that are highly vulnerable to climate change have strengthened food systems and are more resilient to shocks all year round **Focus area:** Resilience building

Activities:

- Provide capacity strengthening to local community members and authorities
- Provide support for protective and risk reduction assets creation and rehabilitation to communities vulnerable to climate-change and natural disasters

Strategic Result 4: Developing countries have strengthened capacity to implement the SDGs

Strategic Outcome 4: Government institutions at central and decentralized levels have strengthened capacities for comprehensive food security and nutrition management by 2030

Focus area: Capacity building

Activities:

- Provide capacity strengthening to national institutions
- Provide evidence-based analysis to relevant national institutions

Monitoring

 More than 90 monitoring visits to the new pilot schools under Outcome 1 of the Country Strategic Plan (CSP) were carried out in August. These schools were visited in order to check their infrastructure and readiness status to be able to begin the optimized school feeding model.

- To assess compliance with targeting criteria under
 Outcome 2 of the CSP, 92 pre-selected households from
 field project activities were visited before the start of
 implementation. This included the random verification of
 eligibility for households that were pre-selected by the
 project committee. All households were confirmed to be
 eligible for participation in WFP projects. More than 120
 monitoring visits were conducted in order to check the
 implementation status of projects and to provide
 recommendations for further enhancement.
- Twenty-nine project proposals from the District Project Committees (DPC) have been submitted for WFP's Project Review Committee (PRC) screening to review the quality and potential impact of proposed field-level activities.
- In August, no complaints about project implementation were registered through the beneficiary hotline.

Challenges

 Green Climate Fund (GCF) Field-Level Agreement negotiations are ongoing at the corporate level beyond the planned 1 January 2019 start date of the project.

Partnerships

- Between 13 and 14 August, the UN Country Team
 Sustainable Development Goals (SDG) Working Group
 convened to discuss the Mainstreaming, Acceleration and
 Policy Support (MAPS) Report findings, review progress
 towards UNDAF outcomes, and operationalize a plan for
 joint UN system support for the SDGs. WFP was engaged
 in developing the UNCT Road Map and Action Plan to
 support the Kyrgyz Republic in implementing the 2030
 Agenda for Sustainable Development.
- On 27 August, the Kyrgyz Republic United Nations
 Operations Management Team (OMT) retreat was held in
 Bishkek with the participation of OMT members from 14
 UN Agencies. WFP has been chairing the OMT since
 2018. The Team discussed the Business Operations
 Strategy workplans and developed an action plan for the
 implementation of the Secretary General's business
 operations targets.
- On 28 August, the WFP Representative had a meeting with the Vice Speaker of the Kyrgyz Parliament Ms. Aida Kasymalieva to discuss the upcoming hearing of the revision of the National School Feeding Law and the next steps of the optimisation of the national school feeding system.
- On 30 August, the WFP Representative had a regular coordination meeting with the Minister of Labour and Social Development to discuss several topics, including the Social Development Strategy.
