

## WFP Haiti Country Brief October 2019

## **Operational Context**

Haiti ranks 168 out of 189 countries on the 2018 Human Development Index. Haiti has one of the highest levels of chronic food insecurity in the world with more than half of its total population chronically food insecure and 22 percent of children chronically malnourished. Underlying drivers of this situation include extreme poverty and frequent natural disasters. On the 2019 Climate Risk Index, Haiti is fourth among the countries most affected by severe weather events.

WFP has been working in Haiti since 1969. WFP's priority is to support the Haitian Government in developing sustainable solutions to hunger and malnutrition to achieve Sustainable Development Goal (SDG) 2 "Zero Hunger".

## **Operational Updates**

Since 16 September, the volatile security environment combined with the fuel shortage has been hampering WFP' efforts to implement its programmes. The two most affected activities were the school feeding and emergency food assistance distributions.

### **Emergency response**

- Due to the security issues, WFP had to postpone cash-based transfers for 70,000 beneficiaries in Grand'Anse, Artibonite and Nord-Est departments, initially planned for October.
- WFP and cooperating partners finalized the targeting of 60,080 beneficiaries, in the framework of a CERF funded response in the Sud-Est department.

## **School Feeding**

 In October, WFP managed to deliver 497 mt of food commodities to 93 schools for 23,250 schoolchildren, reaching 63% of the total of WFPassisted schools.

## **Monitoring and Evaluation**

 WFP's hotline is a feedback mechanism to strengthen control and accountability and the monitoring of programme activities. In October, WFP received 64 calls most of them related to the current situation, which impacted school deliveries and cash distributions, postponed due to insecurity.

 Provide emergency food assistance and support risk reduction and the recovery of crisis-affected populations

#### Activities:

- Design, implement and strengthen nutritious-sensitive safety nets
- Provide daily nutritious school meals

Strategic Outcome 3: Smallholder farmers have improved their livelihoods to increase food security

Focus area: Resilience building

#### **Activities:**

- Provide support to smallholder farmers to sell agricultural products
- Provide daily nutritious and 100% local school meals (Home Grown School Feeding)

## **Vulnerability Analysis and Mapping**

• The Integrated Food Security Phase Classification (IPC) results have been published. They are showing that between October 2019 and February 2020, it is estimated that over 1 million people are in an Emergency food security situation (IPC Phase 4) and over 2.6 million people are in a Crisis food security situation (IPC Phase 3). This represents approximately 3.7 million people in need of urgent action to protect and save lives and livelihoods.
