# Haiti Transitional Interim Country Strategic Plan, Revision 4

#### 1. RATIONALE

- 1. The Haiti transitional interim country strategic plan (T-ICSP) was approved in June 2017 and was extended through revision 2 until 30 June 2019, after which activities will be implemented under the framework of the Country Strategic Plan starting 1 July 2019.
- 2. Upon donor request to increase activities before the end of the T-ICSP, WFP Haiti will allocate more funds than initially planned to Strategic Outcome 5, activity 7 "Provide Technical Assistance to the national social protection safety net programme on vulnerability targeting".
- 3. In 2017, WFP Haiti received a multi-year contribution from DEVCO (2017-2020) to conduct surveys in the Nord-Ouest department, in order to expand the coverage of the information system managed by the Ministry of Social Affairs (SIMAST) to register household vulnerability and target social protection programs developed by WFP and the Government. Five additional communes need to be urgently assessed in order for DEVCO to start implementing activities through its partners, yet these surveys were initially planned to take place during the second semester of 2019, under the CSP.
- 4. In 2018, WFP Haiti also received a contribution from USAID-FFP to extend the coverage of SIMAST to the Nord-Est department. Given donor restrictions related to the use of funds by 30 June 2019, four communes will have to be surveyed during the T-ICSP.

#### 2. CHANGES

### Strategic orientation

5. This revision of the T-ICSP involves no strategic changes.

## Strategic outcomes

6. The revision will only increase resources devoted to Activity 7, in order to carry out household surveys in the Nord-Ouest and Nord-Est departments.

### 3. COST BREAKDOWN

7. The total budget increase of the Strategic Outcome 5 is USD 2,848,773 (including indirect support costs). Funds for capacity strengthening will increase by USD 2,614,671 and implementation costs by USD 84,651.
