





## Joint evaluation on collaboration among the UN Rome-based agencies

## Summary of the terms of reference

**Background**. As part of their approved programmes of work for 2020-2021, the evaluation offices of the Food and Agriculture Organization of the United Nations (FAO), the International Fund for Agricultural Development (IFAD) and the United Nations World Food Programme (WFP) are undertaking an independent joint evaluation of collaboration among the UN Romebased agencies (RBAs). The Governing Bodies of IFAD and FAO requested this evaluation.

**RBA collaboration framework.** In November 2016, the RBAs jointly published a paper, "Collaboration among United Nations Rome-based Agencies: Delivering on the 2030 Agenda", which posits a common vision (SDG2) of ending hunger and malnutrition and promoting sustainable agriculture and rural transformation through holistic approaches. The 2016 RBA Collaboration Paper identified four pillars of collaboration: working together at the country and regional levels, cooperating at the global level, collaborating on thematic knowledge, and joint corporate services. In June 2018, building on those same pillars, the RBAs signed a five-year tripartite Memorandum of Understanding (MoU) that sets out agreed objectives, principles and areas of collaboration.

**Evaluation scope.** The evaluation will cover collaborations between two or three RBAs under the four pillars set out in the RBA collaboration framework and the MoU (2018). The primary focus will be on collaboration at country level, as this is where collaboration should ultimately impact on the lives and livelihoods of people and contribute directly to the SDGs and Agenda 2030. This focus is not to the exclusion of the other pillars of RBA collaboration.

**Evaluation approach and methodology.** The evaluation will comply with the norms and standards for evaluation of the United Nations Evaluation Group and adopt a rigorous approach to ensure the quality and credibility of the evaluation. It will address four key questions articulated around the following areas: a) Relevance, b) Results, c) Enabling and disenabling factors, d) Added value of collaboration. The evaluation will use the criteria of **relevance**, **coherence**, **effectiveness**, **efficiency**, **and sustainability**, applying the revised criteria definitions of the Development Assistance Committee of the Organisation for Economic Cooperation and Development.

**Evaluation Team.** An independent evaluation company, Mokoro Limited, has been hired to conduct this evaluation and will ensure its independence and credibility. An Evaluation Management Group consisting of senior evaluation officers from the three RBAs (Rachel Sauvinet Bedouin, Senior Evaluation Officer, OED-FAO; Chitra Deshpande, Senior Evaluation Officer, IOE-IFAD; and Deborah McWhinney, Senior Evaluation Officer, OEV-WFP), will supervise and provide guidance and quality assurance of the evaluation process and products.

**Risks and mitigation strategies**. The Covid-19 pandemic represents the most serious risk to the completion of the entire evaluation by 31 December 2021. To address this risk, briefings, interviews and main data collection will be done remotely if travel restrictions are still in place.
