Management Response from WFP South Sudan Country Office to the recommendations of the decentralized evaluation of Food Assistance for Assets in South Sudan (DE/SSCO/2019/054) from March/2016 to December/2019

- 1. This document, finalized in June 2021, presents the management response to the recommendations of the evaluation of Food Assistance for Assets (FFA) Project in South Sudan.
- 2. The evaluation, which was commissioned by WFP South Sudan Country Office covers FFA activities implemented from March 2016 to December 2019. The purpose of the evaluation is to inform the implementation of the FFA project in the next Country Strategic Plan (CSP) cycle starting in 2023; it serves the dual and mutually reinforcing objectives of accountability to stakeholders and learning for WFP and partners. Users of the results include staff from the WFP Country Office, Regional Bureau Nairobi (RBN) and Headquarters, beneficiaries, the Government of South Sudan, the United Nations Country Team, non-governmental organizations and donors.
- 3. The evaluation made nine key recommendations with [Y] actions. The matrix sets out whether WFP agrees, partially agrees or disagrees with the recommendations and sub-recommendations. It presents the planned (or taken) actions, responsibilities and timelines.
