1. RATIONALE

The rationale for this budget revision is to reduce the duration of the existing country strategic plan by one year to align with the cycle of the United Nations sustainable development cooperation framework (UNSDCF) 2023-2027 for India.

The current country strategic plan runs from 1 January 2019 to 31 December 2023. The subsequent country strategic plan (2023-2027) is currently under development, and both recognize consideration of this budget revision and align to the time period of the India UNSDCF (2023-2027).

2. CHANGES

Strategic orientation

There are no changes in strategic orientation.

Strategic outcomes

There are no changes in strategic outcomes.

Beneficiary analysis

There are no direct beneficiaries in the country strategic plan, as it focuses on country capacity strengthening.

Transfers

There are no changes in transfers, with capacity strengthening as the only modality.

3. COST BREAKDOWN

The cost of the approved plan for 2023 (USD 3,521,316, excluding indirect support costs) was removed from the overall budget, as indicated in Table 1 below.

This budget revision also includes an increase of direct support costs of USD 250,000 for 2022 to compensate for underbudgeting (9 percent) in the original plan.
