#### 1. RATIONALE

- 1. This budget revision undertaken to reflect internal adjustments in Chad Country Office's (CO) plan for direct support cost (DSC) within the current country strategic plan (2019-2023). The revision will allow the country office to respond to operational exigencies to programme new contributions at full cost recovery (FCR).
- 2. This revision has reclassified and adjusted the CSP (DSC) budget to reflect an increase of USD 5 Million to enable the CO to programme funds at FCR. The proposed DSC BR will not impact the on-going budget revision at the country office.

#### 2. CHANGES

## Strategic orientation

- 3. This budget revision is a technical revision and does not include any new strategic orientations.
- 4. The CO has exhausted the amount that was initially planned under the DSC in the current CSP. The total planned DSC of USD 33.3 million has been already generated, and CO is not able to generate any additional DSC. In consequence, the CO is no longer able to programme new contributions at full cost recovery (FCR), which is a principle that governs all contributions.
- 5. Through this budget revision, the DSC shall be increased by USD 5 Million to enable CO to programme contributions at FCR.
- 6. This budget revision (BR02) will not impact the other ongoing revision (BR03), which captures an increase in beneficiary needs for the year 2023. The CO will have to review the DSC planning in this budget revision and ensure that it is adjusted BR03.
