# India country strategic plan, revision 1

#### 1. RATIONALE

- 1. This budget revision aims to adjust cost increases across all CSP Outcomes as a result of additional costs to move to a new office space and an organisational realignment exercise.
- 2. This revision covers the entire duration of the CSP 2023-2027.

## 2. CHANGES

## Strategic orientation

- 3. There is no change in the strategic orientation of the CSP.
- 4. This is the first budget revision under this CSP.

## Strategic outcomes

- 5. There is no change in the CSP strategic outcomes.
- 6. The increase in staff costs is due to (i) an increase in the number of national staff to better match implementation needs, and (ii) the upgrade of some national staff posts and the conversion of long-term service contracts to fixed term positions. These changes are in line with the recommendations of a staffing realignment exercise conducted in February 2023.

- 7. Estimated costs linked to a new office space were taken into account for the preparation of the country strategic plan approved in November 2022. Via this budget revision, updated estimated costs based on on-going property surveys are integrated in the budget.
- 8. The reduction in transfer value associated with Capacity Strengthening under CSP Outcome 3 is due to the re-classification of Monitoring and Evaluation (M&E) staff members from Capacity Strengthening to Implementation Cost based on the CPB guideline.
