# DELEGATION OF AUTHORITY FOR APPROVAL: CD

# 1. RATIONALE

1. This budget revision (BR02) makes several operational adjustments to Egypt's Country Strategic Plan (2023-2028) to enable WFP to respond to the Sudan crisis while ensuring preparedness measures are in place to respond to other regional crises as needed.

Specifically, BR02 will:

- i. increase the number of beneficiaries receiving in-kind assistance under Activity 01;
- ii. introduce a new activity (Activity 07) under CSP Outcome 03 for the provision of ondemand services to government, humanitarian and development actors; and
- iii. increase the overall budget by USD 7.6 million.
- 2. Since the onset of the Sudan crisis in April 2023, displaced populations continue to seek refuge in Egypt, with Government of Egypt estimates as of March 2024 indicating that 500,000 people from Sudan have sought refuge in Egypt, with over half (267,227) having registered as refugees with the United Nations high Commissioner for Refugees (UNHCR).<sup>1</sup> In collaboration with other actors, WFP has been providing in-kind food assistance at the border crossings into Egypt to populations displaced from Sudan to meet their basic food and nutritional needs.
- 3. Focus group discussions with newly arrived refugee households and community leaders have found the food security and economic situation to be dire, particularly for those not receiving

humanitarian assistance. On average, households consumed only one nutritionally inadequate meal a day, comprised only of basic commodities such as tomatoes, bread, pasta, and fava beans. Many households were also found to resort to negative coping strategies to meet their basic food needs, including limiting the number of meals consumed, selling their belongings, and begging for food.

4. Emergency response in Egypt is led and coordinated directly by the Government under the leadership of the Ministry of Social Solidarity. In the initial response to the Sudan crisis, WFP was called upon by the Government to provide support to other actors, including to the United Nations Children's Fund (UNICEF), the United Nations Population Fund (UNFPA), and the International Organisation for Migration (IOM), enabling the rapid provision of support to vulnerable displaced communities through the use of WFP's efficient registration and distribution platforms. WFP provision of on-demand services will enhance the Government's capacity, as well as that of other humanitarian and development actors, to respond to urgent humanitarian needs and support the most vulnerable crisis-affected populations in Egypt.

# 2. CHANGES

# Strategic orientation

5. BR02 incurs no changes to the strategic orientation of the CSP, however the BR will add a new activity and corresponding output under CSP Outcome 03 as follows:

[NEW] Activity 07: "Provide on-demand services to government, humanitarian and development actors."

[NEW] Output 7.1: "Government, humanitarian and development actors have access to on-demand services, including WFP's cash transfer mechanisms, to enhance their capacity to reach targeted populations in Egypt."

# CSP outcomes

#### Targeting approach and beneficiary analysis:

- 6. Under Activity 01, in coordination with UNHCR, WFP will continue to target the provision of lifesaving in-kind general food assistance (GFA) to displaced crisis-affected populations arriving at border crossings into Egypt. Based on the increased needs identified from the ongoing Sudan crisis, WFP will target an additional 12,000 beneficiaries with in-kind GFA as an initial response. Through the existing cash-based transfer (CBT) component of Activity 01, WFP will continue the provision of life-saving food assistance to targeted beneficiaries once they reach their city of destination. Targeting will be carried out using a community-based approach with defined criteria for assistance, including refugee status and food insecurity.
- 7. During 2024, WFP will collaborate with UNHCR (through the Joint UNHCR-WFP Programme Excellence and Targeting Hub) to carry out a comprehensive food security assessment to better understand and respond to the food and nutrition needs of displaced populations arriving to Egypt. The results of this assessment will further inform the vulnerability targeting criteria for both agencies.

#### Service provision:

8. On-demand services will be provided under new Activity 07 to Government, humanitarian and development actors, supporting the Government's overall capacity to meet the needs of crisis-affected populations. Services include providing partners with access to WFP's existing cash transfer platform for the provision of cash transfers to targeted populations, providing logistical services for emergency and other types of responses, and providing partners with access to information management and software systems to support emergency preparedness and



response, including database software for geographical information systems (GIS) and monitoring.

#### Partnerships:

9. Under Activity 07, WFP will coordinate efforts with the Government of Egypt, especially with the Ministry of Social Solidarity, and with other humanitarian and development actors, including United Nations sister agencies, to design and implement needed services. WFP will continue to partner with UNHCR through the Joint UNHCR-WFP Programme Excellence and Targeting Hub for the planned comprehensive assessment to be carried out by the Center for Public Mobilization and Statistics (CAPMAS) which will inform vulnerability prioritization and targeting of Sudanese and other crisis-affected populations for both agencies. Moreover, WFP will continue the successful collaboration with United Nations sister agencies such as UNICEF, UNFPA and IOM through the provision of services in support of vulnerable populations.

# Accountability to affected populations, protection risks, restrictions of gender and disabilities:

10. In order to ensure greater accountability to affected populations targeted for emergency food assistance through both in-kind and CBT assistance modalities under Activity 01, WFP provides newly arrived displaced populations with access to WFP's Community Feedback Mechanism (CFM) hotline and to other feedback mechanisms which are being scaled-up to effectively and efficiently support the increased number of crisis-affected people.

#### **Risk Management:**

- 11. The political instability in the region, stemming from conflicts in neighbouring countries, poses a significant risk to the stability and effectiveness of WFP operations in-country, potentially changing the scope and nature of WFP's crisis response portfolio in Egypt. To address this, WFP will continue to monitor the geopolitical developments in the region, update preparedness plans, and coordinate as appropriate with the Government and other humanitarian actors to enable WFP to be able to adapt quickly as needed to meet the needs of crisis-affected populations.
- 12. The heightened demand for service provision, particularly during emergencies, places an additional burden on WFP staff and increases the risk of existing activities being deprioritised. WFP will address this risk through careful consideration and augmentation of the current workforce, providing appropriate training and filling staffing gaps through recruitment and temporary deployment as needed. This proactive approach ensures that WFP can deliver services with excellence and can effectively meet the escalating needs without compromising on the quality or efficiency of programming.

#### 3. COST BREAKDOWN

13. The main increase in the budget pertains to CSP Outcome 01, Activity 01, to accommodate the increased caseload of beneficiaries who will receive assistance. WFP has also increased the budget allocation under CSP Outcome 03 to provide on-demand services in support of the Government of Egypt and other humanitarian and development actors in their delivery of assistance to crisis-affected populations.
