BACKGROUND

This document presents the WFP management response to the recommendations from the decentralized evaluation of WFP's USDA McGovern-Dole International Food for Education and Child Nutrition Programme support in Haiti from September 2020 to April 2023 on school meals. The purpose of the evaluation was to assesses the project's progress and long-term effects from its start in 2020 to April 2023.

The evaluation made a total of eight key recommendations with 21 sub-recommendations. The response presented below sets out whether WFP agrees, partially agrees, or disagrees with the evaluation recommendations and sub-recommendations. It presents the planned (or taken) actions, responsibilities, and timelines.
