1. RATIONALE

- 1. On October 29, 2025, Hurricane Melissa (Category 3) struck eastern Cuba, severely impacting Santiago de Cuba, Granma, Holguín and Guantánamo. The storm's winds, rains, floods, and landslides destroyed crops, food reserves, livelihoods, and household essentials. Already weakened by drought, recent flooding, and a deep socioeconomic crisis marked by prolonged recession and inflation, the affected provinces now face worsening conditions and sharply reduced household incomes.
- 2. Hurricane Melissa has created an unprecedented and highly complex emergency in eastern Cuba, marked by widespread and intense rainfall across five provinces, saturated soils from previous storms, a fragile epidemiological situation due to high rates of arboviral diseases, and a weakened energy system following the shutdown of several thermoelectric plants, fuel shortages and frequent power outages.
- 3. WFP received additional funds to deliver assistance to the people in Cuba affected by the Hurricane Melissa.
- 4. This budget revision reflects the confirmed contribution aimed at strengthening WFP's food assistance response to the evolving needs in the country. The update is essential to ensure the timely and effective use of resources in response to Hurricane Melissa.
- 5. The nature of the revision is to increase the Direct Support Cost (DSC) by USD 615,454 and ISC USD by 40,005 to be able to absorb the contribution amounting in USD 13,920,601. It is important to note that WFP can absorb the contribution at the SO level. Therefore, this CSP revision concerns only the DSC.
- 6. The revision covers the period from 15 November 2025 to 31 December 2025.
- 7. There is no change in the duration of the CSP.
