


Update on the guidance on the United Nations sustainable development cooperation framework and common country analysis 19 November 2019 | David Kaatrud, Director Programme-Humanitarian and Development Division (PHD)



- No longer a one-off event, but a "living document". All UNCTs are expected to update their CCAs by 2020.
- CCA is expected to cover all pillars of United Nations work in-country and determine "who is being left behind, and why?"
- CCA has potential to highlight food security & nutrition challenges, opportunities and gaps in achieving SDG2.
- WFP will actively contribute to the CCA, making available relevant data and analysis, including Zero Hunger Strategic Reviews; and working in coordination with the RBAs, UNICEF and other partners.
- Second generation Zero Hunger Strategic Reviews are not intended to be new processes but will be integrated into the new CCA process and build on previous work.

UN Sustainable Development Cooperation Framework (UNSDCF)

- Cooperation Frameworks (UNSDCFs) will be synchronized with National Development Planning cycles.
- United Nations Development, Humanitarian and Peace programming instruments will continue to exist side-by-side but be better aligned.
- Development outcomes in agency planning documents (e.g. WFP CSPs) will be derived from the UNSDCF, and country level programme cycles will align with UNSDCF cycles.
- The UNSDCF roll-out is in full swing. United Nations Country Teams throughout the world are engaging in the first wave of UNSDCFs.
- Headquarters and regional bureaux are working closely with country offices that are embarking on their UNSDCF-aligned CSP/ICSPs.
