L3 Response in Bangladesh to Sudden Influx





613,000 refugees reached Bangladesh since 25 August 2017.



678,000 (152,000 families) people reached rice, lentils and oil every two weeks.



282,500 people received High Energy Biscuits (HEBs) on arrival.



69,000 pregnant women, nursing mothers and young children receiving SuperCereal.



Logistics Sector Hub established at Ukhiya (16 Mobile Storage Units).



Phase 1: WFP needs USD 77 million to feed all 1.9 million refugees until Feb 2018.



Phase 2: March-December 2018 targeted feeding, livelihoods and Host Community support.

L3 Response in Bangladesh to Sudden Influx





Issues of concern:

- Nutrition:
 - 24.4% GAM.
 - 7.5% prevalence of SAM.
- "Mega Camp".
- Hazards: Cholera, fire, cyclone, floods/landslides, acute waterborne disease.

L3 Response in Bangladesh to Sudden Influx





Opportunities:

- > CBT/SCOPE roll out:
 - Multi-wallet biometric card.
 - Target 700,000 new refugees and 200,000 beneficiaries in the host communities.
- Medium-term activities:
 - Fuel Efficient Stoves (SAFE): Joint proposal with FAO IOM and WFP.
 - Livelihoods expanded in host communities.
 - Self-reliance cash for work for refugees.

➤ Post-25 August Government Security Operations.

Agreement with Red Cross Movement.

Resumption of WFP Operations.

Assessments.

CRF: Implementation and refinement.
