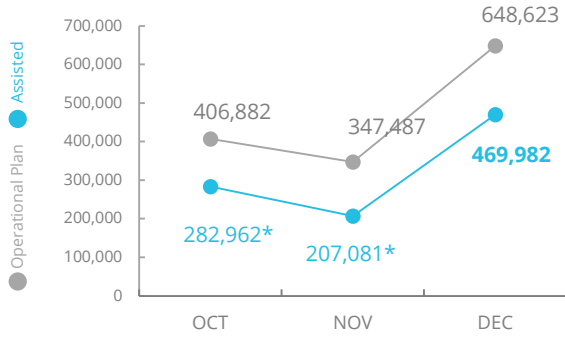

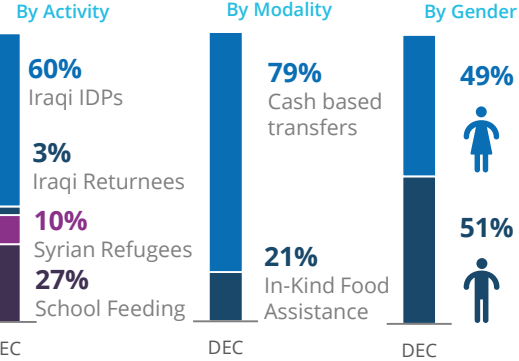

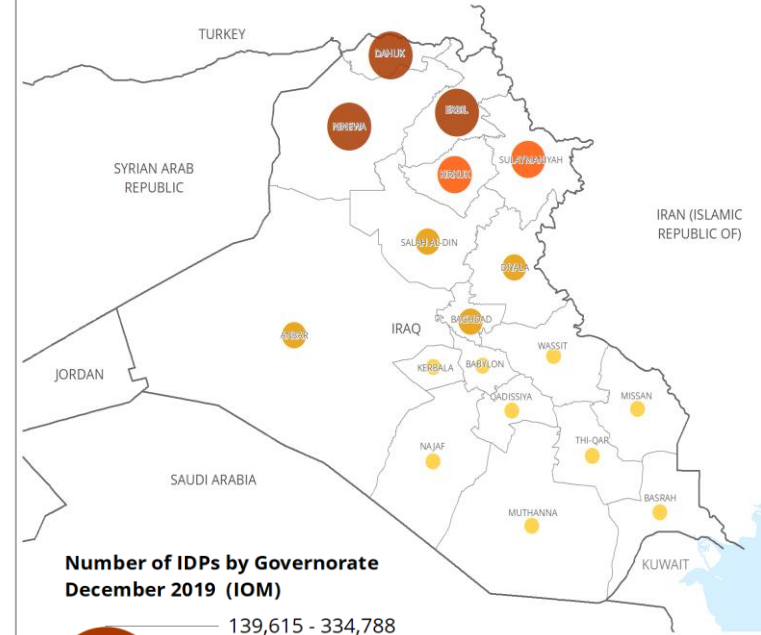

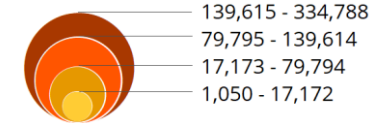

## IDPs BY LOCATION AS OF DECEMBER 2019

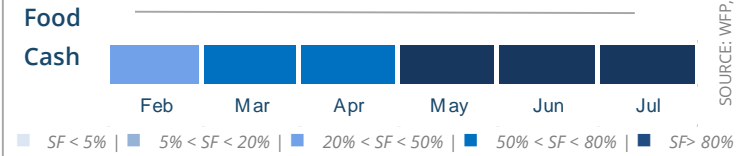


### Number of IDPs by Governorate December 2019 (IOM)

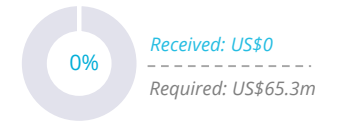
## EXPECTED SHORTFALLS\*

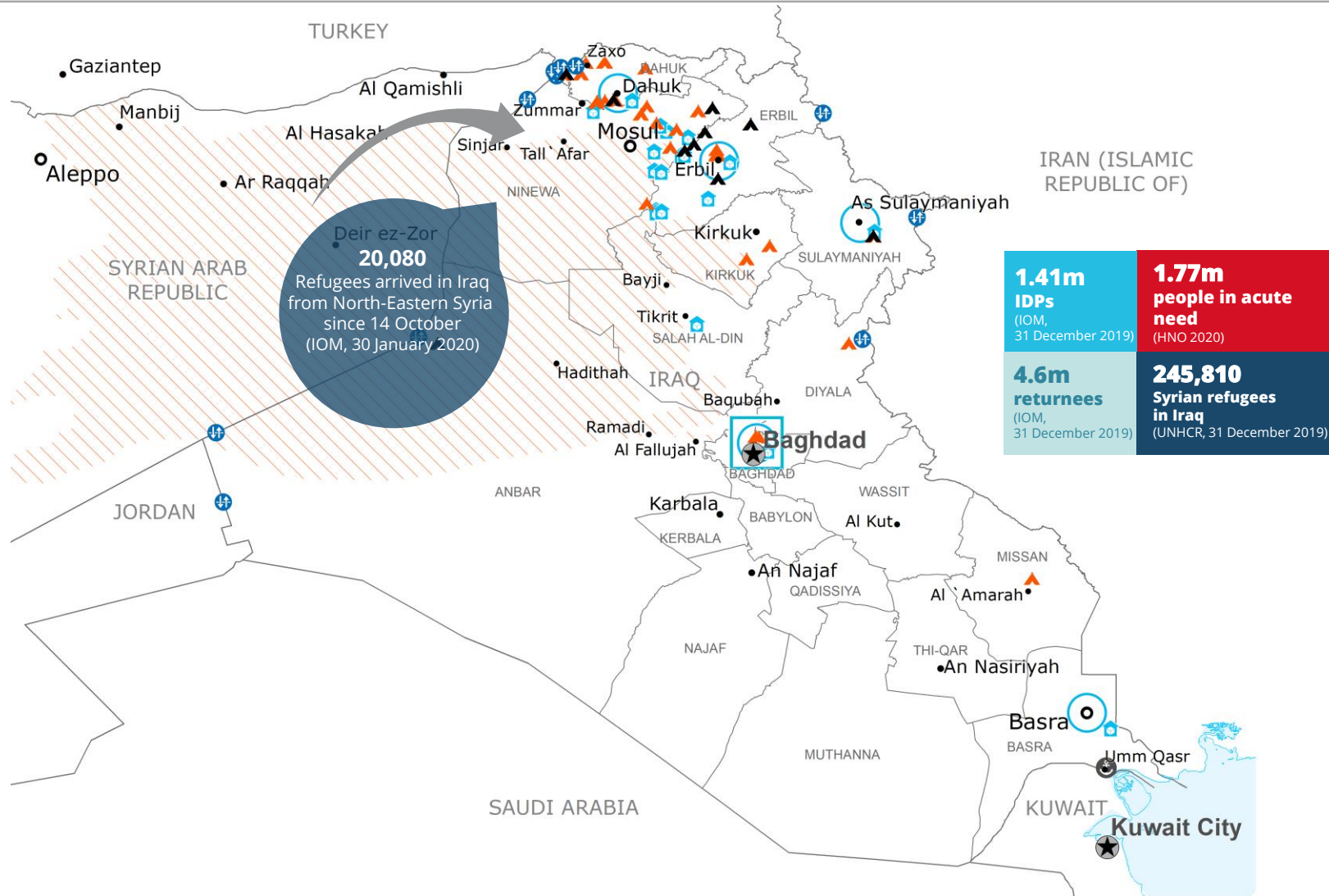
